**AMENDMENT TO MASTER SERVICES AGREEMENT
(Apollo After School)**

This Amendment to Master Services Agreement ("**Amendment**") is effective as of November 7, 2020 ("**Effective Date**") and is entered into by and between the Board of Education of the City of Chicago, a body politic and corporate, commonly known as Chicago Public Schools located at 42 West Madison, Chicago, IL 60602 ("**Board**" or "**CPS**"), and Apollo After School with principal place of business located at 4450 N Central Avenue, Chicago, IL 60630 ("**Vendor**").

RECITALS

- A. To respond to the COVID-19 pandemic which resulted in remote learning at CPS schools, the Board and Vendor entered into that certain Master Services Agreement for remote learning supervision services for a term commencing on September 28, 2020 and continuing through November 6, 2020 ("**Original Agreement**").
- B. The parties now desire to amend the Original Agreement to extend the term as hereinafter set forth below. The Original Agreement and this Amendment shall be referred to herein as the "**Agreement**".

NOW THEREFORE, in consideration of the foregoing Recitals, which are incorporated herein as though fully set forth herein, and for good and valuable consideration, the parties agree as follows:

- 1. **Definitions:** Any and all capitalized terms shall have the same meaning as defined in the Original Agreement unless otherwise defined herein.
- 2. The following items in the Original Agreement are hereby amended:
 - a. **Term:** The parties agree to amend the Term and extend it by an additional four (4) months; the Term is amended to commence September 28, 2020 and continue through February 28, 2021 ("**Extended Term**"), unless terminated sooner as provided in the Original Agreement.
- 2. **Services:** During the Extended Term, Vendor shall continue to provide the Services described in the Scope of Services in the Original Agreement.
- 3. **Compensation:** During the Extended Term, Vendor shall continue to be compensated for the Services in accordance with the terms described in the Pricing Section of the Scope of Services in the Original Agreement.
- 4. **Freedom of Information Act:** Vendor acknowledges that this Amendment and all documents submitted to the Board related to this contract award are a matter of public record and are subject to the Illinois Freedom of Information Act (5 ILCS 140/1) and any other comparable state and federal laws and that this Amendment is subject to reporting requirements under 105 ILCS 5/10-20.44. Vendor further acknowledges that this Amendment shall be posted on the Board's internet website at www.cps.edu.
- 5. **Agreement:** Except as expressly provided in this Amendment, all terms and conditions of the Original Agreement are and shall remain in full force and effect during the Extended Term.
- 6. **Counterparts and Electronic Signature:** This Amendment may be executed in any number of counterparts, each of which shall be deemed to be an original, but all of which together shall constitute but one instrument. A signature delivered by facsimile or other electronic means shall be considered binding for both parties.
